- Where the interest is no longer a 'Sensitive Interest' you must notify the Chief Executive Officer within 28 days of that change.
- For the purpose of this Register, reference to Councillor is taken to include an elected or co-opted member to the Parish Council.
- 6. West Berkshire Council's Monitoring Officer is required to ensure that a copy of the Town Council's Register of Members Interests is available for public inspection and also that the Register is published on the Town Council website or West Berkshire Council's website.

- I confirm that I understand and accept that that it is a breach of the Parish Council's Code of Conduct to:
 - (1) omit information that ought to be given in this Form;
 - (2) provide information that is materially false or misleading;
 - (3) fail to give further notices in order to:
 - bring up to date information given in this Form;
 - declare an interest that I acquired after the date of this Form and have to declare.

and that any breach of the Code of Conduct can be referred to West Berkshire Council 's Monitoring Officer for action.

c. I understand that failure (without reasonable excuse) to register or disclose any disclosable pecuniary interest in accordance with section 30(1) or 31(2), (3) or (7) of the Localism Act 2011, or participating in any discussion or vote in contravention of section 31(4) of the Localism Act 2011, or taking any steps in contravention of section 31(8) of the Localism Act 2011 is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a member for a period not exceeding 5 years.
