

The Civic Manager declared that Councillor Billy Drummond is also a Member of West Berkshire Council, which is declared as a general interest on their behalf and a dispensation is in place to allow him to partake in discussions relating to West Berkshire Council business.

23. Art on The Park

Cllr Sue Farrant reported that following discussions with Newbury & District Arts Association and Newbury Art Group, they have members who are very enthusiastic about the prospect of getting Art on the Park back up and running. It was also reported that Newbury Art Group have a small pot of money which they would be keen to use for this project.

It was agreed that Cllr Farrant, Cllr Foot and Cllr Drummond would arrange a meeting with Newbury Art Group to look at the scope of getting this event back up and running, with an aim for Summer 2021.

It was noted that the success of previous events was dependent on volunteer stewards. Cllr O'Keeffe suggested contacting the Corn Exchange to see if any of their volunteer stewards may be interested.

24. Newbury Art Trail

The Civic Manager reported on the outcomes of a meeting with Cllr Farrant, Cllr Foot, Cllr O'Keeffe and Jane Shillam from Newbury & District Arts Association.

It was suggested for further research to take place into the history of the art pieces in Newbury, and to make use of the website to publish information, which can be updated as and when required when new information about pieces is discovered. Another small meeting with the Civic Manager and the Councillors listed above will take place before the next meeting.

The Civic Manager also advised that there were further earmarked reserves budgeted for the Town Trail to be used. Cllr Farrant agreed to approach Greenham Trust to look at the possibility of match funding for any potential future projects.

25. Newbury Town Civic Awards

The Civic Manager presented detailed plans for the 2021 Civic Awards, which included plans for a Launch Event (and Covid 19 contingencies) and ideas for a new Community Champions Award.

The Deputy Leader of the Council suggested an open competition for the design of a pin badge for the new award. The Civic Manager and Chairperson will further investigate this, sharing ideas with the rest of the Committee before the next meeting.

26. Heritage Open Day

28. 75th Anniversary of VE Day 8th May 2020/VJ Day 15th August 2020

The Chairperson reported on the events that took place on the 8th May and 15th August. It was noted that they were appropriate commemorations for the current circumstances, and they were well received.

The Civic Manager thanked all those who participated in the VE/VJ 75th Anniversary Commemorations Working Group.

The Civic Manager explained that circumstances regarding this year's Remembrance Sunday will be under constant review and will be subject to change at any time in the lead up to the event itself.

A number of ideas and suggestions were put forward by Members, the Civic Manager agreed to share at the next Remembrance Sunday planning meeting.

Newbury and District Arts Association

18 November 2020

In common with many organisations, the past eight months have been challenging for local arts groups. The arrival of the Covid19 pandemic and the national lockdown in March saw all group activities and performances curtailed. The arts community has shown creativity and resourcefulness in maintaining a presence and continuing activities, albeit in a modified form. This has largely involved making use of internet platforms.

Professional organisations, such as the Corn Exchange, Watermill Theatre and Newbury Spring Festival offered and developed their online resources. The Corn Exchange and Watermill returned to mounting live performances adhering to strict safety policies defined by government guidelines. Audience capacity is much reduced with a resulting loss of income. Although these local, professional organisations have been successful in obtaining some emergency funding, the continued significant income shortfall has huge implications for their future.

Music and drama groups have been particularly badly affected by the necessary restrictions due to the Covid pandemic. There has been good advice from the 'umbrella' organisations such as 'Making Music' regarding running 'virtual' rehearsals and events. They have provided detailed information about resuming live rehearsals under the government regulations but the nature of the virus and its transmission via droplets and aerosol, are not compatible with singing and wind and brass playing. Several local societies have attempted a mixture of live and virtual rehearsals with varying degrees of success.

Visual arts have perhaps been better suited to adapting to virtual platforms. There have been photography club and 'open studio' exhibitions, and art and craft classes delivered online.

The efforts to maintain this limited level of artistic activity have been admirable and national lobbying on behalf of the arts has helped to raise their profile. However, this cannot compensate for the huge sense of loss felt by so many of us now that both active and passive participation in our favoured artistic and cultural activities is so severely restricted.

On the positive side, this has drawn attention to the value and contribution that the arts make to our wellbeing and that of society as a whole. Local arts groups are making plans for activities and events in 2021. We all hope that efforts to contain and control the Covid pandemic will enable the vibrant cultural activity in Newbury and its environs to resume and enrich our lives.

Agenda Item 7: Newbury Art Trail

Background

Councillors Nigel Foot, Sue Farrant and Elizabeth O'Keeffe have been working closely with the Civic Manager to look at reinstating a presence of the Town Trail within Newbury. Discussions took place about how to progress the sharing of information about the Town Trail and the design concept and working with other Newbury Town Council Committees and external stakeholders to promote and develop the Trail.

Councillor Foot (also Chair of the Council's Town Centre Working Group which reports to the Planning and Highways Committee of Newbury Town Council), said that it would be advantageous of any information coming from Civic Pride, Arts and Leisure Committee, regarding the Town Trail, to be forwarded to the Town Centre Working. West Berkshire Council, who also sit on the Town Centre Working Group, have commissioned 'Hemingway Design' consultants to advise on the regeneration of the Town and help with the development of the Local Plan. It was hoped this move would help works of art to be incorporated into the planning of future developments.

This proposal mainly comes from that the initial idea for the Art Trail comes from the initial concept of 'flow', an initial concept which Newbury Town Council came up with when creating the art trail over 20 years ago. Every art piece that has been commissioned reflects the design concept of 'flow'. There are fears that this concept may be lost when it comes to future developments and requires enforcing to keep the history of the theme of 'flow' present within the town.

The initial concept of 'flow' that is used for the art pieces is very broad. In 1999, local artist Michael Fairfax produced the design concept, suggesting possible sites and works all linked by the theme of 'flow' The theme represents many things, from the flow of people, of goods, of water, of ideas, of vehicles and, more recently, of electronic data and information, through Newbury. The concept was accepted by the Council and it was decided that the first piece should be a sculpture which incorporated flowing water, which is now what we know as the Ebb & Flow sculpture.

Agenda Item 8: Newbury Town Civic Awards 2021

Background

The Newbury Town Civic Awards was launched in 1998 and has been thriving and growing ever since. The Civic Awards Presentation sees our Town's 'unsung heroes' recognised for their efforts and contributions to the Town. In 2009, we launched the Young Person's Civic Award, 2018 saw the launch of the Business Civic Award and 2020 introduced the award for Environmental Contribution to the town. Winners of the awards receive a prize, as well as their name being presented in the Town Hall. All nominees are invited to the Awards Ceremony and everyone, including the winners receive a certificate from the Mayor.

2020 was the first year in 23 years that the Awards Ceremony was unable to take place due to the Coronavirus pandemic. Instead, all nominees and winners received their certificates in the post alongside a letter of congratulations from the Mayor. A press release with a full list of nominees was issued and able to be accessed on our website. The winners are still due to receive their physical awards.

Due to the uncertainty of the world situation, contingency plans have been put in place for the 2021 Civic Awards Scheme.

LAUNCH DAY

Due to the ongoing uncertainty of Covid, unfortunately we will be unable to host the Civic Awards Launch Event in the Town Hall as originally planned which would also celebrate the achievements and success of 2020's nominees and winners.

Instead, we will revert to launching a press release to let all know that the nominations for the awards are open, with all important information on how they can nominate and key dates.

Winners of 2020's Awards still need to collect their physical awards, in January we would invite the winners to the Town Hall to meet the Mayor to collect their award and to get a photo which would be included as part of our press release.

The Launch would also announce the winner of the Community Champion's Pin Badge Design Competition. The drawing of the design will be showcased and the winner will receive a prize for their contribution when invited to meet the Mayor, and their design produced in time for March's Awards.

AWARDS PRESENTATION

For the Civic Awards Ceremony, we would look into utilising technology to deliver this. This may potentially be a video live stream on the evening of the 17th March, or a pre-recorded video presentation filmed in advance which will be uploaded to our social platforms on the 17th March. This would be edited accordingly with on-screen text to support those with accessibility requirements.

While it may not be possible to invite the winners of the awards to collect their prizes, it would be arranged for the four large award winners to be invited to collect their awards and for a photo opportunity in the Town Hall when appropriate.

The winners of the Community Champion Awards will have their certificates and pin badges sent to them in the post. All other nominees and winners will also receive their certificates in the post.

The Newbury Town Community Champions & Pin Badge Competition

This is a special, one-off award specifically for the 2021 awards to recognise those individuals who have come forward to give their time, energy and support to fellow members of the community out of kindness and goodwill during the Covid-19 pandemic.

Instead of having one overall award, as this is a one-off occasion it is suggested that those nominated are all recognised as a Newbury Town Community Champion by receiving a special pin badge for their services to the town and residents. The criteria for this award would be to have delivered unpaid, voluntary service, to help support the local community during the Covid-19 crisis. By keeping criteria broad, we hope to attract a range of nominations, some which Newbury Town Council may not have heard of before who have contributed in our community.

A competition will be launched on 7th December 2020, targeting youth groups and young people to partake in the opportunity to design the pin-badge that will be produced and given to the recipients of this award. This will span over the Christmas/New Year period with the winner being chosen in time to be notified for the launch of the Awards.

Competition entry forms will be available to download via the Town Council Website, and physical copies will be sent to schools, youth organisations, West Berkshire Library. A separate press release of this competition will be launched in December.

The entry form will provide a template of the space where the pin can be designed, and guidance on art work specifications from the pin badge supplier (enamelpinfactory.com). The brief will be to 'design a pin badge which celebrates the community spirit of Newbury', and entrants will be required to write a written response to the question 'what was the inspiration behind the design you are submitting?' to help support their entry.

Financial and Legal Implications

The current budget provision is £1000. Sponsorship worth £500 from Newbury Racecourse was due to be used in 2020 but it was agreed that this would be deferred to 2021.

Reference to the Council Strategy

It is an objective of the Council to run and sponsor an annual Civic Awards scheme (Strategy Objective 2.C1).

By introducing the Community Champion Award we will also be congratulating residents and members of the community when significant achievements are brought to our attention (Strategy Objective 2.C2)

Equality and Diversity Impacts

The awards are open to all the communities in Newbury.

Agenda Item 9: Heritage Open Day 2020

The Town Hall usually runs a Heritage Open Day event in the Council Chamber inviting the public into the Town Hall to learn about the history of the building and more about Newbury heritage. 2019 was a success, welcoming around 140 visitors into the Town Hall.

This year, Heritage Open Days have been encouraging organisations to look at alternative means of engagement though the use of digital technology. While the Town Hall is unable to open to the public, the Civic Manager has explored means of how a Heritage Open Day presence can be done digitally. Unfortunately, due to the Council's current IT infrastructure and time constraints, we wouldn't be able to deliver the advanced options of digital experiences Heritage Open Days were advising.

Alternatively, this year the Town Council utilised our notice boards to provide a Heritage Open Day display as well as an online quiz being available. Both of these were able to be accessed throughout the duration of the Festival from Friday 11th September – Sunday 20th September. These would work in tandem to inform one another, essentially the information from the poster would feed into the questions that were asked in the online quiz.

The online quiz was made using Google Forms, as there was technical issues with TypeForm – the original programme that was going to be used to create the quiz. Because of this, the quiz had fewer interactive elements than would have liked and wasn't as visually engaging as hoped. The quiz itself consisted of 15 questions, categorised into the Town Hall Building, The Mayor of Newbury, Regalia, our paintings as well as some further questions about key dates in the Council's history.

While the link to the quiz was shared on our website, social media platforms, in a press release and a QR Code was included in the poster, engagement was very low with only 7 participants across the whole festival. This was very disappointing for the amount of time that went into researching the questions and trying to solve the technical issues by switching platforms.

Participants had the opportunity to leave feedback on the quiz. Only one participant left written feedback saying "this was quite a challenging quiz, but very interesting none the less to learn about some of the Town Hall history". The average score on the quiz was 9 out of 15. The median rating for the quiz difficulty, with 1 being 'easy' and 5 being 'very hard' was 3.5, with a range from 2-5.

An A1 Poster was produced and placed in the building's notice boards. The poster included a QR Code link to the online quiz and information that we would normally

provide as hand-outs on our open days. Upon reflection, the poster was very text-heavy and wasn't an accessible document produced. While there was a few pictures of the Civic Staircase and the Mayor's Parlour, there should have been a more visual focus and better presentation of the poster – a lesson to learn from and take forward for the future.

For the future, I think it is important to dedicate more time to Heritage Open Days to make sure that the rich history of the Town Hall is celebrated appropriately, regardless of if we host an open day or continue to present the Town Hall in a digital capacity. With many other organisations taking part virtually this year, it will be interesting to read the evaluation reports from Heritage Open Days to gauge ideas and inspiration for the future.

Recommendations for 2021:

- To keep optimistic in the hope of being able to deliver our Town Hall Open Day as successfully as 2019, taking onboard feedback from that year.
- Keep an eye out on the theme for 2021's event to see if we can have a more focused presentation. 2020's theme was 'Hidden Nature' which wasn't considered throughout planning arrangements.
- Continue to further learn and develop digital skills and opportunities to showcase the Town Hall's heritage digitally.
- To ensure more time is dedicated to prepare for future Heritage Open Days Festivals

Agenda Item 10: Remembrance Sunday 2020

Remembrance Sunday Service 8th November 2020

Due to the Coronavirus pandemic, this year's Remembrance Sunday event was very different to what we would usually deliver.

With plans everchanging due to new restrictions, this year's event consisted of a heavily stripped back service and wreath laying ceremony taking place at the War Memorial only, with no parade or use of the Market Place at all this year. With a National Lockdown announced to commence from the 5th November, many plans for the Service had to be reviewed and changed very last minute in order to comply with new laws and legislations that were provided for delivering Remembrance Sunday by the Government.

Attendance was restricted to only those who were laying a wreath on behalf of wider represented groups, which mean that we were sadly unable to have Councillors, Officers, Veterans and the many other uniformed members and volunteers present who would usually come and pay their respects every year. We also sadly were unable to deliver a service at St Nicolas Church this year either.

The message this year, taking a joined-up approach with both Thatcham and Hungerford Town Councils was to 'Remember From Home'. 2020 saw the first year that Newbury's Remembrance Sunday would be video live streamed and radio broadcast via Kennet Radio, promoting the message to Remember From Home.

One of the legal requirements that was needed for all Remembrance Sunday events in 2020 was to ensure mitigations were in place to deter crowds from gathering, and also to have Track and Trace systems in place for those that were attending on the day. The solution to this was to form a controlled event space around the War Memorial, cordoning off the area to members of the public by using pedestrian barriers, only granting those who had received an official invitation access to the event space. Their details were provided in advance to constitute as Track and Trace, and they were ticked off the guestlist upon entering the space on the day.

On the day itself, everyone in the event space adhered to social distancing and mask wearing was encouraged. Revd Keri Eynon delivered a reduced service, providing reminders to not sing the National Anthem due to guidance (which was played out loud by Kennet Radio), and encouraged everyone to leave the area following the end of the service in a safe, socially distanced fashion.

Anyone who hadn't received an invitation, or wished to lay their own wreaths or flowers was invited to do so in their own time following 11:30am, once the event has finished and all the pedestrian barriers had been removed. This offer was taken up by many, including many youth organisations who wished to visit the War Memorial in their own time.

While there was roughly 100 members of the public who did turn up on the day to pay their respects, many used the opportunity to tune into either the video or radio live stream. This was a first for Newbury Town Council, and while there was a slight technical issue in set up of the video stream, this was quickly rectified before the stream was due to begin.

There were many positive comments regarding this years' service which seemed a lot more poignant and emotional than previous years due to the world's circumstances. Many comments expressed their praise toward the quality of the video and radio streams and the quality of the service that was presented in a virtual capacity, something which would be recommended to continue doing for future years. There were also positive comments regarding the Senior Standard Bearer, Angela Logue, directing the wreath laying procedure and announcing who was laying a wreath and whom they were representing, although the audio wasn't picked up during streaming.

The Royal British Legion provided feedback to us about receiving complaints from veterans who were unable to attend the event space after the event had taken place, and we did have one public complaint to the Town Council in writing about this and how there was last minute changes to who was able to be allowed into the event space. Unfortunately, due to the last-minute change in laws, the event required further reduction in size and attendance to ensure compliance with the laws in place, and the matter was resolved to an understanding in a wash up meeting that took place on the 18th November.

It was agreed that following the wash up meeting, in Summer 2021 the Royal British Legion and the Town Council would come together to discuss plans for operations of 2021's event with the hope that a usual parade and service would be able to continue as per previous years.

I would like to add my personal thanks to all at Newbury Town Council for their support and understanding in what unforeseen and very different circumstances this year's event has taken place in. I would also like to thank Thames Valley Police and West Berkshire's representatives of the Safety Advisory Group for all their guidance and support. The coordination of this year's event came with its challenges, but overall considering 2020's circumstances, Remembrance Sunday this year was a success. We were able to deliver a short, focused service and wreath laying

ceremony and reached audiences in a way which we have never explored previously. I hope that the skills, experiences and additional technical elements can be utilised accordingly for 2021 where 'normal service' can resume.

4. Schools Update

The Civic Manager notified the Working Group that letters had been sent out to all schools notifying them that the event in the Town Hall due to take place in October was no longer going ahead. Emails were also sent to the lead contacts of the schools who had their confirmed scheduled visits. A note was written at the bottom of the letters encouraging schools to keep an eye out on future events and ways to engage young people in local democracy.

The Civic Manager had so far received no responses from these messages but will share any responses with the rest of the Working Group.

5. Zoom Event

Cllr Gary Norman presented a report from a meeting with Cllr Martha Vickers and Cllr Nigel Foot providing a basis and ideas for an online event to encourage young people to engage with the Council.

The ultimate purpose of this event is with an aim to restart Newbury Youth Council, which an aim for the Zoom to take place early 2021.

There were discussions about the age of the target audience. It was decided that the age should be kept broad from 'Year 7 to A Level' students, with an emphasis on keeping content relevant for all ages and starting from Year 7 to engage younger students with the Council for a longer period of time.

Target organisations should not just be restricted to secondary school but to also include Newbury College, youth organisations and clubs, Berkshire Youth, pupil referral units etc.

Once an agenda for the Zoom meeting has been put together, means of publicity include leaflets and letters to target organisations, usual Council outlets, and an emphasis on Social Media.

In their discussions, it was agreed that further research needs to be done regarding an agenda, with a need to talk to experts on what is engaging young people now in political conversations. Examples include the environment, diversity (Black Lives Matter), Mental Health etc. Other items could be suggested by target organisations.

There were strong proposals to have a group facilitator for the Youth Council sessions, potentially a youth worker, ex teacher, a volunteer who is used to working with young people from a diverse range of backgrounds.

The Civic Manager confirmed that encouraging a Newbury Youth Forum/Council is included in our current strategy (Reference 2D.2b in strategy document)

It was agreed that the next main priority is to find a focus for the Zoom event and to attempt to find a facilitator.

ACTION: Councillors Gary Norman, Martha Vickers and Nigel Foot to meet again to further research an agenda for the Zoom meeting and a facilitator, providing further focus for the Zoom event. This will be reported on at the next meeting.

3. Zoom Event

Councillors Gary Norman, Martha Vickers and Nigel Foot presented the findings from a meeting that took place on the 6th November with representatives from Berkshire Youth and Community United West Berkshire to discuss the best format to engage the youth voice.

Outcomes of the meeting from the experts suggested that the best means was to not predefine the event with the aspiration to form a Youth Council but to launch the process with a specific theme for discussion, and using the theme as a hook for engagement.

This theme would be determined by asking young people to engage in an online survey to help determine themes which are important to them, and to set up the Zoom event with the theme based on the outcomes of the survey. The survey would consist of a couple of short questions (e.g. What 3 things would make your life better in Newbury?) to help determine some themes.

The idea has been well received by Berkshire Youth and Community United who are very happy to engage in sharing the survey on their platforms. The Civic Manager would assist in setting up the online survey.

The next step would be to take the proposal to the next Civic Pride, Arts and Leisure Committee taking place on 30th November where a timeline would be discussed for progressing the online survey.

The Civic Manager will amend the notes provided by Cllr Gary Norman to a proposal that will be shared with the Committee. These will be shared with Cllrs Gary Norman, Nigel Foot and Martha Vickers in advance of going into the public domain.

The Chairperson thanked Councillor Norman, Councillor Foot and Councillor Vickers for their hard work on this.

4. AOB

There has been no further contact from the primary schools regarding the cancellation of the sessions in the Town Hall. Will review the circumstances in the New Year to see if/when their visits would be viable.

Agenda Item 11: Local Democracy Working Group

Background

The Local Democracy Working Group has previously engaged with secondary school students by visiting their schools in October hosting Q&S sessions with Councillors. Following evaluation, it was agreed that the offering for secondary school students should be more targeted to the topics that they are interested in.

In these discussions, it was also noted that there may also be some strong, passionate young people who have a keen interest in politics who may wish to be a part of our currently dormant Newbury Youth Council, which had previously been established many years ago and used to be a very active group and initiative. However, how to engage with young people to be a part of this, and the concept of a Youth Council's functionality was questioned if it would be appropriate for young people today, and if the way we engage with youth should be reconsidered.

Councillors Gary Norman, Nigel Foot and Martha Vickers have been doing further research into what would be best practice to engage young people in local matters and to give young people of Newbury a voice. With the current circumstances of Covid-19, best practice is to engage with young people through online means and video call to discuss local issues. To gauge further insight into this, the Councillors proceeded to research further which included a meeting with representatives from Berkshire Youth and Community United West Berkshire to discuss the best format to engage the youth voice.

Outcomes of this meeting with the experts in the youth sector suggested that the best means was to not pre-define an online event with the aspirations to form a Youth Council or a Youth Forum, but to launch the process with a specific theme for discussion which is relevant to young people in Newbury, and the use the theme as a hook for initial engagement.

Experts recommended that the theme should be determined by young people themselves, and the process should be launched by setting up an online survey for young people to answer simple questions (e.g. What three things will make your life better in Newbury? Etc) which, in turn, will help determine some key themes that young people in Newbury care for. This will act as a basis for engaging young people in online discussions, using their suggested themes as a hook for engagement.

Reference to Council Strategy

2D – Encourage and support contributions to our public and community life. With reference to point 2D.2b; introducing young people to local democracy and NTC, and encouraging a Youth Forum/Youth Council

Financial

To make sure the work of the Youth Voice is appropriately administered, a proposed budget of £5000 is in place to help implement the survey and the online youth event to take place in the new year.

Equality and Diversity

This survey would be welcome for all young people in Newbury to participate in. It would be an opportunity to capture what young people, from a varying degree of backgrounds, care about within the town to ensure that the overarching project delivered is inclusive for all within Newbury.

The outcomes of the survey could also feed into other work of the Council which works to promote further equality and diversity initiatives from the Town Council.

Consultation

This idea has been well received by Berkshire Youth and Community United who would be happy to engage in sharing the survey on their platforms if the recommendation is passed.

The Civic Manager would assist in setting up the online survey and promoting it to our local secondary schools and youth focused projects and groups in Newbury.

The survey would be managed by Newbury Town Council but will be shared with Berkshire Youth, Community United and other local youth organisations to encourage engagement.

Recommendation

To set up an online survey to capture the views and areas of interest for young people living in Newbury

To analyse the results of the survey

To arrange and implement an online youth event in the new year on a theme selected using the results of the survey.

The Civic Manager maintains a spreadsheet of dates booked and Councillors availability.

The Civic Manager gives a phone call to each school one week before the event to remind schools to attend.

2/3 members of the Group prepare/update and deliver the presentation. Other members of the Group and any other Town Councillors available attend as support for the Primary Schools Sessions and as part of the Secondary school visit program.

Agenda Item 12: The Corn Exchange Learning Centre

Background

The Corn Exchange Newbury is a vibrant hub for arts and culture within the town, which has suffered greatly due to Covid-19. The arts sector has been hit hard by the pandemic, and The Corn Exchange building has subsequently had to close for business from March 2020. While they briefly opened the building again in September, they had to drastically change the way they operate with a reduced programme and cancellation of many events, including those in their Learning Centre.

The Learning and Participation team works to support vulnerable, isolated and disadvantaged members of the community, by putting learning and wellbeing at the heart of its work, using the arts as a vehicle for delivery in the Learning Centre. One of the major challenges for the Learning Centre is that the Learning Centre has had since re-opening in September is the need to restrict attendees to their sessions in order to remain Covid safe with some sessions limiting their capacity to 50%, with the prospect of some sessions running at a loss or sessions being cancelled.

While these adaptations have had to be made, the future for the Learning Centre is looking financially challenging with the potential that some practitioners may not be able to run anything in Spring 2021.

The Corn Exchange have emphasised the value that the Learning Centre has on many in our local community and the loss the organisation, and it's participants would feel if the Learning Centre programme was no longer on offer.

Strategy

Financial

The Corn Exchange have requested £10,000 to go toward their funding package to subsidise some of the regular creative sessions that take place in their Learning Centre for local people of all ages and abilities.

The activities in the Learning Centre provided by the Corn Exchange outline their audiences and cater for all ages and abilities, providing inclusive opportunities to take part and access to the arts within Newbury.

Supporting the Corn Exchange's Learning Centre programme—Get Involved

The Corn Exchange has a long relationship with Newbury Town Council and is extremely grateful for its previous support, most recently for *Reach Out* and *Unlocked & Unbolted* via *The Good Exchange*. We are now writing to ask the Council to consider providing an additional funding package of £10,000 to subsidise some of the regular creative sessions that take place in our Learning Centre for local people of all ages and abilities. Our sector has been extremely hard hit by the pandemic and these sessions also provide a viable income for our talented practitioners and freelancers, many of whom live locally and have suffered severe loss in income over the past eight months of the pandemic.

In this proposal we have set out some information about the Corn Exchange and the impact of COVID-19 and lockdown on our organisation, specifically the impact to our Learning and Participation work. We go on to describe how we are adapting to survive and the extent of our funding shortfall. At the end of our proposal we described in more detail the extensive work of our Learning Centre and how it provides inclusive opportunities to take part and access the arts.

About us

The Corn Exchange is a flagship arts centre in the heart of Newbury, delivering outstanding performances, creating our own well-respected work and providing a rich mix of arts and cultural provision to as many local people as possible. The Learning and Participation team works to support vulnerable, isolated and disadvantaged members of the community, by putting learning and wellbeing at the heart of its work.

As set out in our 2019-2020 Impact Report (available on our website and attached separately as part of this proposal), in the last year prior to March 2020, we sold over 86,000 tickets for over 1,160 shows—across all activities and buildings this amounted to a staggering 131,239 engagements!

This included 28,167 engagements with our Learning Centre from which we run our participation programme *Get Involved* supporting families, older people and young people. We want to safeguard this legacy for the future!

The COVID-19 pandemic has resulted in an extraordinarily challenging time for our industry, but the support from our local community has been so significant over recent months—and has made us more determined than ever to keep our activities going when we know just how valuable the arts and culture are for people's wellbeing.

Impact of the pandemic

The financial impact of COVID-19 on our organisation has been huge. We closed our buildings on 17 March 2020 and with the majority of our events cancelled or rescheduled until 2021, our ability to generate income from ticket sales and learning and participation activity has been drastically reduced. Programme and related income losses will be close to £1 million for 2020/2021. Now, a second lockdown is impacting all of our activity and we face a further loss of ticket and associated income during this time.

A major challenge for the Learning Centre is that we've had to restrict the number of attendees in all of our sessions in order to remain COVID-safe; this leaves us with the prospect of having to cancel some sessions to avoid running at a loss or in other circumstances running two sessions and therefore needing to pay two sets of practitioner fees. Support from the Council for our learning programme means that the Corn Exchange can continue to pay fair guaranteed fees to our practitioners, even though sessions are operating at reduced capacity.

Supporting us in this way would give the Council involvement in a real breadth of our community engagement activity across the year and we hope would be an attractive proposal for the Civic Pride, Arts and Leisure Committee. Ultimately this subsidy will allow us to continue to strengthen our work around social isolation and wellbeing which otherwise may not be feasible.

Looking forward

As we begin to adapt and reopen, our Learning Centre programme has returned, with a reduced social distanced capacity, and is being delivered as a blended programme of inperson and online activity, ensuring that those who are not yet ready to return in person have the opportunity to remain creative.

Social distancing requirements for the Learning Centre to ensure the safety of our participants have limited our capacity by at least 50%. We try hard to keep the cost of courses affordable and at the same time offer a guarantee of viable fees for practitioners whilst covering our costs. Currently the picture is looking very challenging financially with some longstanding practitioners indicating that they will not be able to run anything in the spring.

The table below shows the impact of reduced numbers of participants on some of our core learning and participation activities for the next 12 months. For 2020/2021 for the activities outlined, this amounts to a shortfall of £14,610.

What we have been doing to survive

To survive, we furloughed the majority of our permanent staff, and reduced and renegotiated overhead costs wherever possible. During lockdown electricity and heating were switched off and contracts with refuse and recycling reduced to a bare minimum. Annual maintenance contracts and insurance remained in place along with payments to our IT providers and Spektrix ticketing system and rent on the Learning Centre and 101.

All of our planning to date has been about getting our organisation to a point where we can operate successfully in a world where COVID-19 is circulating.

One week into lockdown we launched our digital engagement programme, running free online creative sessions to support those staying at home to use cultural activity to improve their wellbeing. We commissioned five artists to create digital initiatives to support this programme; devised a youth theatre project giving voice to young people's experiences of the pandemic; and created a community choir film that went viral. This programme of work has engaged with over 7,000 people to date.

Over the summer we created COVID-secure workplaces. We welcomed artists back to 101 from July, and with COVID-19 protocols and the *Visit England We're Good to Go* certificate in place, began to reopen our buildings and activity in September, with the aim

of maintaining our staff team at current levels. We initially repurposed our main auditorium as a cinema. Our live programme has been minimal with just a handful of producers prepared to present events at our reduced capacity of 115. Our family offer has been particularly popular, showing a clear need to engage in cultural activity.

We have been able to present a small number of socially distanced live performances as well as resume some of our engagement activities, and have recently announced, following a reconfiguration of our seating, that our annual pantomime will be taking place this year although the implementation of a second lockdown has left us an even more precarious position, threatening our ability to present our pantomime or any live performances in 2020.

At the same time, we launched a major fundraising campaign, *Save Your Corn Exchange: Fund the Future*, to raise vital financial support to protect our future. During the campaign, we are asking all our audiences and supporters to consider donating, whilst also seeking further support from a range of partners. As we work to overcome the challenges presented by COVID-19, our aim for the Save Your Corn Exchange: Fund the Future campaign is to raise £100,000. As of 19 November 2020, we have raised over £40,000 through the generous donations of our audiences, members, local Trusts and other partners. However, even with this and a funding award from the Cultural Recovery Fund, we face a significant financial loss this year. But we believe it is vital to continue our learning activities in order to create joyful artistic experiences for our community.

The Learning Centre

The Corn Exchange launched the Learning Centre three years ago. It offers a wide range of diverse and inclusive social and creative opportunities through our *Get Involved* programme. People of all ages and abilities have the chance to take part and learn a new skill, meet new people and nurture their creative sides!

- Children and families—We create opportunities for families, particularly those with children aged 5 and under, to learn and create together through one-off and weekly sessions such as Storytime Online, #dreamOUT (a short tale and activities to engage children and inspire adults), Makaton Clue of the Week and Maketon Rhymetime Online, and Infant Dance Online and Toddler Dance Online
- Young people—We work with young people, ages 7 to 25, who have an interest in the performing arts and cultural industries through dance, arts management, placements and projects. Interested young people can take part in weekly sessions with our professional theatre practitioners such as *WISE* our resident male youth dance company, *Junior Dance (Drop in)* and *Arts Award Clinic Online*
- Adults—We deliver courses, workshops and groups for all levels of experience, including social groups and more formal learning experiences. We have moved live courses online during our second lockdown. These include Afternoon Art, Start with Art, Still Life Drawing, Clay Class, Writing for Performance (for exploring play-writing to monologues to performance poetry), Thank Friday It's Improv!
 Online, Dance for Parkinson's Online and Tai Chi Qigong Online
- Older people—Now in its third year, *Ageing Creatively* explores creative ways for the over 55s to engage in the arts at the Learning Centre, community venues, and in

care settings. The programme offers workshops, projects, and courses across art forms and includes singing, poetry, dance, and visual such as 'The Home Collection' (four online *Dare to Dance* sessions), *Sing 55 Social Online*, *Pilates Online* and *Contactless Creativity*

"As a result of performing on stage I feel safer when I am more visible. As a result of Dare to Dance I feel better about my body and more positive about my health."

Schools and educational settings— We are enthusiastic about building partnerships
with local schools to provide creative and effective learning opportunities both within
and outside the curriculum. An extensive menu of workshops and annual projects in
support of the curriculum, literacy and personal development such as *Wellbeing Warriors* which we ran in August to introduce children to the idea of 'Wellbeing' and
the five ways to wellbeing.

"At the beginning of the project I felt nervous and worried and now I feel confident in myself. I have learned that I don't have to hide myself and be worried. I was very shy but I learned how to cooperate effectively. I have learnt I need to trust people more. You need to trust people."

Participant feedback

We understand the demands being made on the Council at this time but believe the difference the Corn Exchange can make to people's lives through engagement with the arts ensures that any funding would deliver real benefits to the community.

This subsidy will allow us to continue to offer excellent and vital participation opportunities to Newbury town residents by subsidising the places lost to due to COVID-19 guidance. This funding will ensure we are still able to operate classes by contributing to our unavoidable costs and overheads, as well as topping up the income of the artists and practitioners we work with to a worthwhile level. Without this subsidy this provision will quickly disappear from our offer as running lower capacity classes is not financially viable and we know from our participants themselves that Newbury would feel the loss greatly if the Learning Centre programme was no longer on offer.
