- 5. For the purpose of this Register, reference to Councillor is taken to include an elected or co-opted member to the Parish Council.
- 6. West Berkshire Council's Monitoring Officer is required to ensure that a copy of the Town Council's Register of Members Interests is available for public inspection and also that the Register is published on the Town Council website or West Berkshire Council's website.
