3. Minutes of the Staff Sub- Committee meeting held on 27 November 2018

5. Civic Manager

The meeting heard that on 3 June Mrs. Joyce Lewis had tendered her resignation, with effect from 31 July. Since then she had offered to extend her notice period to 30 September to facilitate the recruitment and induction of a replacement Civic Manager.

Resolved: that with regret, the Council accepts the resignation of Mrs. Joyce Lewis from the post of Civic Manager and agrees to extend her notice period to 30 September.

The meeting considered the report presented by the Chief Executive Officer detailing arrangements for the recruitment of a replacement Civic Manager. This included a recruitment plan, the job description (JD), person specification (PS), advertisements and contract details for the post. The Sub-committee made some minor amendments to the JD and PS before agreeing all of the proposed arrangements.

The meeting considered the report received from the Community Services Manager recommending that the Job Description and Employment Terms of Community Services Officer, Joanne Lemprieire be amended to take account of her additional responsibilities and developmental role in managing Richie Sharpe, the Town Hall Caretaker.
