## Agenda Item 8: Newbury Town Civic Awards 2020

The 2020 Awards were launched at the beginning of February 2020. A press release launched the awards encouraging members of the public to collect nominations forms from the Town Hall or to email requesting a nomination form. Following technical difficulties, nominators were able to complete the forms online via the Newbury Town Council website for a further 5 weeks.

We received the following number of nominations:

Civic Award - 13 Young Persons Award - 3 Business Award - 3 Environmental Contribution Award – 5 TOTAL – 24

Sadly, due to the coronavirus pandemic, the decision was taken to cancel the awards presentation due to take place on 1<sup>st</sup> April 2020. However, because we had already received all nominations it was decided for judging to still proceed and for the Awards to be issued.

Judges this year included the Mayor of Newbury; Chairperson of Civic Pride, Arts and Leisure Committee Cllr Jo Day; Operations Manager at the Newbury BID, Alison Drummond; and Chairperson of the Climate Change Working Group Cllr Chris Foster who joined specifically for judging of the Environmental Contribution Award. Judging took place on a Zoom conference call.

It was a difficult task for the judges, as we received a high number and such a high quality of nominations, however winners were selected for each award. The Civic Award winners were Steve & Jan Pye. Young Persons award winner was 9-year-old Jacob Halling. The Business Award winner was Mathew Groves from Greggs, Northbrook St. And finally, the winner of the Environmental Contribution Award was Marion Fenn.

All winners, nominees and nominators were notified of the results of the awards. A press release was issued, and a full list was published on the Newbury Town Council website. At an appropriate time, we will invite the award winners to come to the Town Hall to collect their prize.

**Resolution:**

# **Background/Introduction**

The 2020 Civic Awards presentation ceremony was sadly cancelled due to the coronavirus pandemic. While Newbury Town Council were still able to issue the awards, the presentation ceremony was missing. The Civic Awards is a fantastic opportunity to celebrate the members of our community who have gone above and beyond, as well as providing a networking opportunity for those in the community who wish to explore further voluntary work which is taking place in Newbury.

It is disappointing that we weren't able to offer the usual presentation ceremony that has been delivered in previous years, especially as 2020 was the first year of the Awards going forward as a stand-alone event to provide all nominees the recognition they deserve.

It is also important to note how much kindness and goodwill has been carried out since Covid-19 came to light. Many businesses, organisations and volunteers have come forward giving their time and energy to support fellow members of the local community in Newbury.

# **Options Considered**

We will be inviting the winners of the 2020 awards to the Town Hall to collect their prizes at an appropriate time. Discussion of when this would be is still to be confirmed. One option would be to incorporate this into a launch event. A launch event would serve as a celebration for 2020's nominees and winners as well as introducing 2021's awards. We would invite all nominated for the 2020 awards to the event so they can enjoy the celebration they were due to have in April, as well as inviting local businesses and community groups to learn more about the awards and have the opportunity network with likeminded community champions. This would be

a good occasion to raise the profile of the awards and encourage additional nominations at the event.

While letters from the Mayor have been sent to many who have supported others during the crisis, there are so many people, both individuals and organisations, who have volunteered in the community to support those in need which the Council may not be aware of. Encouraging the public to nominate people who have responded to the Covid 19 crisis may highlight others who would be worthy of recognition. The 2021 Awards would be an opportunity to introduce a new award for those who have responded to the Coronavirus pandemic. Considerations on how this would work are to be discussed; options could be one overall award or a small prize of recognition (such as a pin badge) for each nominee in this category.

# Reference to the Council Strategy

It is part of the council strategy to celebrate and recognise individual community achievements. (2C)

This is through our objective of running the annual Civic Awards scheme (2.C1) and to congratulate members and residents of the community whenever significant achievements are brought to our attention (2.C2)

# **Finance**

The current budget provision for the Civic Awards is £1000. This was double what budget was originally available to host the Civic Awards as a standalone event. While a Launch Event would require some of this budget, there may also be potential opportunities for sponsorship from local businesses.

Newbury Racecourse agreed to sponsor 2020's Civic Awards event however as this was cancelled, they since informed the Civic Manager that they would be happy to defer their £500 sponsorship to 2021's event.

# Equality & Diversity

The awards are open to all of the communities within Newbury Town.

# **Recommendation**

- 1. That the Council resolves to introduce a Civic Awards launch event for 2021
- 2. That the Council resolved to introduce a new award to recognise those who have responded to the Coronavirus pandemic.

# Agenda Item 10 : Christ's Hospital School

To consider the endorsement of the West's Gift scholarship available to young people in Newbury.

# **Background**

Christ's Hospital was founded in 1552 by King Edward VI, who during his very short reign established three 'hospitals'. St Thomas's Hospital 'for the relief and care of sick children', Christ's Hospital 'for the education of poor children' and Bridewells 'for the correction and amendment of the idle and vagabond (those who move from place to place with no fixed address)'. Since then, Christ's Hospital has grown into one of the leading independent public boarding schools in the country with a tradition in scholarship, music, the arts and sport. The school itself is very special because it relies on the donations from many generous beneficiaries, including that of John and Frances West.

John and Frances West lived in the latter part of the 17th and early part of the 18th centuries. John West became a wealthy merchant in the City of London and lived in a house on the site that is now occupied by the Mansion House. John married Frances Seakes from Reading, the granddaughter of the Mayor of Newbury, Gabriel Cox in 1627 and 1635.

John and Frances had no children of their own and the 'Standard Pedigree', maintained by Christ's Hospital, records the name of descendants of their relations. This charity established under the wills of the Wests', provides income for the benefit of children resident in the boroughs of Reading, Newbury, and Twickenham, together with one girl from the City of London.

There are no accurate records going back as to how many children have been supported by Wests' Gifts at the school, but what is clear is that the numbers of those from Newbury have varied widely over the years; peaking at 42 children from Newbury alone. It is likely that at least 2000 children from the three boroughs have benefitted from the West's Gifts over the years, at a cost, in today's terms of £120Million.

It is tradition that Newbury Town Council invite the West's Gift scholars to the Christmas Carol Service, and they would be presented a small token gift from the Mayor. This tradition has been lost through the years, however 2019's service welcomed one West's Gift scholar, and her family, and was presented with a book token. In February 2020; the Mayor, Deputy Mayor and the Civic Manager took the opportunity to visit Christ Hospital school to learn more about the school and the West's Gift method of entry.

# **Options Considered**

Following February's visit, Christ's Hospital School were certainly interested in rekindling an old relationship and would be very happy to welcome more Councillors to visit the school to learn more about their history.

Their marketing method for targeting Newbury and the surrounding area is by directly contacting the local schools to gauge potential interested pupils and parents in boarding school life with the prospect of the West's Gift bursary.

One proposition, upon approval, would be to arrange a visit for some of our school link Councillors to see the school and learn more about the admissions process using The West's Gift method of entry. This would the provide a basis for conversations with each school and the provision for the schools to further learn more about the process to interest pupils and their parents as a potential option for secondary education.

# **Recommendation**

That the Council resolves to endorse the Christ's Hospital School's West's Gift available for students living in Newbury.

## Civic Pride, Arts & Leisure Committee – 6 July 2020 Agenda Item 11: Mayor's Cadet

To consider the procedure developed to recognise the role, and appointment process of Mayor's Cadet.

## <u>Newbury Town Council</u> <u>Guidelines for the Mayor's Cadet</u>

Newbury Town Mayor may nominate an outstanding young person to become their Cadet for their term in Office. The Cadet's formal duties will be to attend the Mayor as and when appropriate in the course of their official duties within the town.

## 1. Selection Process

The Mayor of Newbury will have the opportunity to select their Mayor's Cadet from any of the uniformed services youth groups in Newbury Town. These include, but are not limited to:

- 211 Air Training Corps
- Newbury & District Sea Cadets
- 14<sup>th</sup> Platoon Newbury Army Cadets
- Newbury CCF
- Newbury Police Cadets
- Fire Cadets
- Boy's/Girl's Brigade
- Scout Explorers
- Girlguiding Rangers

The Mayor of Newbury will approach a uniformed youth group of their choice. They will ask the Commanding Officer/Group Leader to nominate an outstanding young person to become the Mayor's Cadet. This person may have won an award in their group or have demonstrated strong commitment, dedication and leadership within their group.

The young person taking on the role of Mayor's Cadet will need to fit the following criteria:

- Aged 16+
- Have shown outstanding commitment, leadership and achievement within their organisation
- Be willing to take on the role
- Confident in interacting with a wide range of people
- Be thoroughly reliable
- Be well presented in their uniform on civic duties
- Be a role model to represent the young people in Newbury Town

It would be preferred if the Cadet was a senior member of their unit and they would be expected to continue their service following their appointment as Mayor's Cadet.

## 2. Installation

The Cadet will be installed by the incoming Mayor. The Mayor will visit the young person's unit base at the discretion of the unit Leader, this may be when a pre-existing presentation at the group is taking place, (e.g. 211 ATC's Cadet of the Year presentation in June).

The Cadet will hold their appointment from the date agreed with the Town Mayor until the end of the Civic Year. This is likely be around an 11 month period.

At the end of the Cadet's term, they will be thanked by the outgoing Mayor for their service and will be presented with a certificate in recognition of their appointment.

## 3. Badge

The incoming Cadet is presented with a commemorative badge with the legend 'Mayor's Cadet'. They will be expected to wear the Mayor's Cadet Badge while on duties during their term in office or sew it onto their uniform at the discretion of their Commanding Officer/Leader. The Cadet may keep their badge following the end of their term.

## 4. **Procession Order & Duties**

The Cadet will process after the, CEO, Chaplain and Mayor but before Councillors.

The Cadet will only attend civic engagements within the Town when Mayor is present, and the Mayor can specifically request their attendance at their charity events if they so wish.

The duties of the Cadets are mainly to carry the Mayor's wreath on civic occasions, assisting with seating guests and guiding them to facilities at engagements, and to promote the youth of the Town.

Annual civic events that the cadet will be expected to attend are; Civic Awards: March/April Mayor Making: May Michaelmas Fair: October Remembrance Service: November Christmas Carol Service: December

The Mayor's Cadet may also be invited to attend Mayor's Coffee Mornings and Fundraising events, Lord Lieutenant and High Sheriff's at home events as well as wreath laying events at RAF Welford and the Greenham Common Control Tower.

A list of key dates will be given in advance for them to attend. This is not exhaustive and can be adjusted by the Mayor as required.

## 5. Welfare

The Cadet will be the responsibility of the cadet's parents/guardian/staff member of the organisation. Contact details of their next of kin will be given to Newbury Town Council upon their appointment in case of emergency. The Mayor's Office may liaise with the next of kin of the nominated Cadet to confirm duties, dates and times that they are required.

The Mayor's Cadet will not be in a situation where they are left on their own with the Mayor and will usually only attend civic matters within Newbury Town. Anything outside of the town that may arise will be at the discretion of the Cadet's next of kin.
