Swings & Smiles Impact Report 2024 – 2025

Introduction

Swings & Smiles is a Thatcham-based charity providing specialist support for disabled children and their families across West Berkshire and neighbouring counties. We are committed to improving quality of life for these families and believe in a world where everybody has the opportunity to thrive and reach their full potential.

As of 30 June 2024, West Berks Council reported that more than 4,000 children and young people required SEN support. These numbers reflect a higher-than-average rate of SEND diagnoses compared to national figures and statistical neighbours within West Berks. West Berks also shows a strong reliance on special schools exceeding national averages.

We currently have more than 1,550 families registered with us. Without Swings & Smiles, many disabled children and their families would have nowhere to access appropriate support and socialisation opportunities. Our sessions are tailored to help reduce isolation, build resilience, confidence and independence. Our growth has been significantly enabled by funding from a variety of Trusts and Foundations. This support has allowed us to expand and adapt our services to meet increasing demand. At Swings & Smiles, we're committed to creating joyful, inclusive experiences that support the whole family.

The Need

Families raising a child with disabilities face immense challenges — emotionally, physically, and financially. Many parents describe the experience as isolating, with limited respite or community spaces that understand their needs.

Children with complex physical, intellectual, or behavioural needs often require intensive 1:1 or 2:1 care, which few providers can accommodate. Siblings of disabled children can feel overlooked and need their own opportunities for friendship and support.

At Swings & Smiles, we provide a unique, safe environment where **families can play together**, **relax and connect**, supported by skilled staff trained in specialist medical, behavioural and communication support.

Demand for our services has reached an all-time high as families desperately seek trusted respite providers and accessible recreational opportunities. The complexity of the children we support has increased significantly with many requiring intensive 1:1 or 2:1 support. These children need constant care and specialist support yet have the most limited opportunities of all. Their parents and siblings undertake the most challenging care tasks, making respite essential for family wellbeing. We give parents peace of mind that their child is being taken care of by skilled and trained staff and that they are in an environment totally suitable for their needs. However, funding is limited and it is becoming increasingly difficult to raise the funds needed for our essential services.

We are guided by the children in each session and use feedback from families to help shape our centre and the services we provide. With over 10 years of experience, we have developed a deep understanding of working with disabled children and their families. Our highly skilled team offers invaluable support to those we serve. Our programme gives children the chance to play and engage with both peers and our dedicated staff and volunteers. We recognise the huge lack of social opportunities for disabled children and support for their parents and siblings. Many families describe our work as a 'lifeline'.

We operate from our unique and fully accessible centre in Berkshire, alongside our outreach service to schools, groups and individuals across a 40-mile radius. Our services run throughout the week — including evenings, weekends, and school holidays - ensuring support is always available when families need it most. Services include respite, youth clubs, family play sessions, sessions for under 5s, home education groups, parent support groups and our successful SIBSupport service for siblings.

Families of children with special needs often report their children don't have access to the same clubs and social opportunities as other children. Finding appropriate recreational activities is challenging. Parents frequently suffer poor mental health due to added pressures and isolation, unable to access what others take for granted. Without Swings & Smiles many disabled young people and their families would be extremely isolated and have no other opportunities to access fun outside of home or school.

The charity is governed by eight trustees with many having personal experience of disability. Our team combines extensive experience working with disabled children and their families with ongoing professional development.

Our experienced and compassionate team uses play as a foundation to build relationships and foster social development. Play is a powerful tool, and we follow

guidance from charities like SENSE to ensure our activities help children develop communication, self-awareness, and connection with others.

Key Programme Areas

Children Aged 0-5

Our **Minis Family Sessions** run weekly across the whole year. We work closely with **Dingley's Promise** and deliver outreach sessions in local family hubs.

We also support **Ollie's Therapeutic Nursery**, an independent OFSTED-registered setting for children aged 3–5 with speech, language, and communication needs. The nursery benefits from full use of our facilities and provides an alternative SEND early years provision. Through our Minis sessions we are able to invite other professionals to help families get early support that improves outcomes at school and at home.

As a family Jenni & Dan, Orlando & Aubree attend both our Minis and our Family Play sessions. As well as free play, at these sessions we come together to take part in planned activities aimed at helping a child's development, whilst having fun. Our Family Play sessions support parents and carers to play with their children, socialise with others and take part in group activities. The interactions that Aubree and Orlando experience at Swings & Smiles make a huge difference to their social development, exposing them to new and different situations in a friendly environment, encouraging growth and learning.

It is so heartwarming to be surrounded by people who truly understand how hard life can be raising SEND children. – Jenni



Family Play

Family play remains at the heart of what we do, supporting the whole family — including grandparents — in a safe, welcoming, and non-judgemental environment. These sessions enable peer connections and create informal support networks that extend far beyond the centre. Our weekend sessions are particularly popular, and are normally full, with a waiting list some weekends.

In the past year, we delivered **5,353 hours** of Family Play. Our large sensory room and garden are highlights for many families, offering crucial sensory input that helps children and parents build stronger, more connected relationships. Parents also benefit from peer support and the chance to celebrate achievements or share challenges.

Feedback from families consistently shows appreciation for the judgement-free environment and tailored activities, which include messy play, sensory stories, and cooking.

Respite Services

Our **after-school, weekend, and holiday respite** sessions support children with the most complex physical, intellectual, and behavioural needs. Spaces are highly sought after, relied on by families and recommended by social workers from the Children with Disabilities Team. The Play Leader team are highly skilled with specialist training to meet the medical and behavioural needs of the children.

Swings & Smiles respite sessions are thoughtfully designed to give children with special educational needs and disabilities the chance to have fun, make independent choices, build friendships, connect with others, and develop essential life skills — all in a safe and supportive environment. We hold individual parent meetings three times a year to develop shared targets and review progress in a collaborative way.

We've seen tremendous growth in our respite services—from 828 hours in 2019 to 7,632 hours in 2024. Our respite programme includes after-school clubs, weekend care, and holiday sessions. Each is designed to meet diverse and complex needs, with trained staff facilitating social interaction and play development.

Challenges remain, particularly in recruiting enough trained staff and volunteers and covering the cost of essential training. Looking ahead, we aim to expand support for those aged 13+, increase participation across all age groups, and enhance community integration.

We have created teen-friendly zones within our outdoor space and an accessible sensory garden, giving young people hands-on experience with growing plants—encouraging shared activities and group engagement. We have also increased community outings as part of respite

Sonny attends our After School Club at Swings & Smiles. At this club parents can drop off their children to us and have some much-needed respite to do errands, spend quality time with one another or simply have time to self-care. It also gives Sonny a chance to grow his independence and socialise with the other children who attend.

Youth Clubs

Youth Club offers an exciting evening programme designed for children and young people from Year 3 to Year 9+, across both mainstream and SEND settings. Through the power of play, young people develop essential life skills such as building confidence, communication, creativity and emotional resilience in a fun and natural way.

Each session is packed with exciting games, adapted technology and a wide variety of inclusive activities that encourage friendship, socialisation and a sense of belonging. Our dedicated team ensures the Youth Club is a safe, welcoming space where every young person can explore new interests, express themselves freely and be their authentic self. At Youth Club, play is both fun and the space in which young people learn, grow and connect.

Thanks to a grant from Greenham Common Trust, we have developed an outdoor space specifically for teenagers. This includes a fully accessible firepit area and an outdoor den.

Since September 2024, we've launched additional youth clubs at The Waterside Centre and added a third session at Easter. These sessions, along with five existing youth clubs at our centre in Thatcham, offer activities like cooking, science experiments, and outdoor sports, helping teens build friendships and social confidence. Over the summer we collaborated with Good Hope Farm so that teenagers and their parents could work in their extensive allotment-style garden developing a range of skills.

Limited funding restricts the number of community outings we can offer—particularly from our Thatcham site—but we are working to expand access to the teen-specific Annexe space.



West Berkshire Council Building Resilience Contract

The Building Resilience Project - which is part of West Berkshire's early help initiative - supports families who are caring for a child with additional needs, pre or post diagnosis. It can be emotionally and physically challenging for parent carers, often leading to stress, isolation, guilt, and grief. These challenges can make it harder for families to access support and increase risk of reaching crisis point. We are seeing more families experiencing domestic violence and extreme levels of poverty which makes the diagnosis of a SEND need even more devastating for families who have been stretched so far. This project aims to provide a bespoke outreach service for families of children aged 3-11 with additional needs, offering early support to reduce the need for further statutory intervention.

What's Going Well:

- Contract renewal with the West Berkshire Early Response Hub
- Strong demand and positive feedback from families and professionals
- Improved efficiency in programme delivery
- Increased referrals to Swings & Smiles from this programme

Challenges:

- High demand stretches resources
- Widespread focus on crisis management limits early intervention work
- A relatively new social work team within our local authority means that we are always their first option and we are being overwhelmed by this demand

Looking Ahead:

- Enhance collaboration with professionals using unified documentation systems
- Incorporate latest research to strengthen our practice
- We are building relationships with higher education to explore opportunities for research and development to understand our community better

Outreach Services

Not all families can access our Thatcham centre. Thanks to our Outreach vans, we take **specialist sensory equipment and sessions** to schools, sports facilities and community venues.

From September 2024 – July 2025, we have supported 79 individuals within 16 schools and 157 individuals across 24 venues, delivering sensory-focused sessions to schools, individuals and events across Berkshire, Hampshire and Oxfordshire.

Key Highlights:

1:1 and small-group sessions addressing sensory needs

- · Sensory play and storytelling to support learning
- · Major event presence at CarFest, Parallel Windsor and more
- · Community trips to Marwell, Legoland, Bournemouth Beach with support from Jumbalance and Cotswold Farm Park.

We also provide a calming Sensory Space at Reading Football Club home games, helping families enjoy matchdays together.



Supporting Education and School Transitions

Our Home Ed sessions have grown significantly—from three children at the start of the year to nine per session, with a waitlist of four. Originally for years 4–8, the programme has been expanded to meet growing need across a wider age range.

We support more families struggling with mainstream school environments. Our **Home Ed sessions**, led by a qualified teacher, include STEM, problem solving, cooking, and social skills. English and maths tuition has been added to the programme this year as the need had been identified.

The **Engage programme** provides a safe space for children on reduced timetables, accompanied by parents or schools, to regulate and learn in a low-pressure setting.

Two children have recently transitioned back to full-time education—a proud milestone for the team. With additional funding, we aim to run two parallel sessions to support even more children.

Feeling comfortable in the home ed sessions Grace was then able to start attending other sessions at the session, including the Spectrum Youth Club. Spectrum has been great for Grace; it has further grown their confidence and has now made a friend in the club. Grace is now always excited to attend the group and is no longer scared. Grace explained that they liked coming home, and they look forward to it on a weekly basis.

Grace would recommend it to anyone who is thinking about the group, and there is nothing that they would change about it.

SIBSupport - Supporting Siblings

Our SIBSupport programme remains a vital part of our work:

- In-person activities Art, cooking, Lego Masters, mystery food challenges, and more!
- School workshops Expanded to include more conversation and peer support

This year, we conducted 70 school visits across 14 schools, supporting 83 siblings through our SiBSupport programme. Our five-week school workshops focus on diagnosis understanding, emotional regulation, and self-care, culminating in a personalized takeaway resource box for each child.

Our SIBSupport sessions at the centre, held both during school breaks and term time, to help siblings better understand and manage their unique family dynamics. As well as meeting and creating friendships with other children who are in similar situations and have more understanding.

Trips to places like paddleboarding/rowing, boat trip along the canal, Local trips to the park offer siblings a chance to enjoy time away and connect with peers in similar situations.

Up to 25 Year olds

We are actively working with the younger age group of 19 – 20 years as they have stayed with us and need our continuing support. We are not advertising this more widely but supporting our young people on their continued journey with Swings & Smiles. We have a new dedicated social session which includes time at the centre and visits to the pub and other social opportunities.

Impact and Outcomes

Our 2025 Annual Feedback Survey shows:

- 97% of families report increased social interaction
- 95% feel their child can access activities unavailable elsewhere
- 92% feel less isolated through our support

These outcomes align with our core charitable objectives:

1. Children with special needs are more socially confident.

- 2. Families spend quality time together in suitable environments.
- 3. Parents and siblings feel more supported and less isolated.

Annual Reach (2024-2025)

- **618 disabled children and young people** had opportunities to socialise and grow independence (579 2023/24; 269 2022/23)
- **637 families** spent quality time together (318–2023/24; 335 2022/23)
- 902 parents and siblings felt less isolated (341 2023/24; 275 2022/23)

In 2024, we provided 7,632 hours of respite care alone, alongside 5,353 hours of family play sessions. Home education sessions have grown from three children to nine per session with a waiting list of four.

Collaboration and Partnerships

Swings & Smiles values strong connections within the community and works closely with many local charities and organisations.

We continue to expand collaborative work, including:

- Regular referrals from West Berkshire Council
- Hosting sessions with speech and occupational therapists
- Close working relationships with Dingley's Promise, Berkshire Youth, PALS, and Mencap
- Sensory support at Sebastian's Action Trust events
- Weekly music therapy provided by Berkshire Maestros
- Hosting low-cost sessions for local specialist schools
- Host of the West Berkshire Parent Carer Forum supporting parents to have their voice heard locally
- Founder member and chair of the Berkshire Fundraisers network
- Chair of the West Berkshire SEND Providers Forum

We are members of the **Disabled Children's Partnership** and **Council for Disabled Children**, contributing to national dialogue on SEND support.

Volunteers and Community Support

Volunteers are integral to everything we do, extending the service that we offer to our families and enriching the community:

We have 55 **regular volunteers** providing a total of 1368 hours with an equivalent value of £16,703.28

We have been supported by 110 Corporate Volunteers from 10 different local businesses providing a total of 535 hours with an equivalent value of £6,532.35

Four **schools** have brought pupils to provide voluntary services

There were **seven trustees** with a commitment of 10 hours a month totalling 840 hours with an equivalent value of £10,256.40

Totalling 2743 volunteering hours with an equivalent value of £33,492.00

Volunteers receive training in safeguarding, medical awareness, and communication. We ensure they feel appreciated, included, and valued.

Ros's Story

Ros will always say that she gets so much more from supporting families than she gives. Ros is a fantastic role model, befriending children and getting to know each child's needs. She builds trust with families and is respected by the team.

Equity, Diversity and Inclusion

We are deeply committed to inclusion — culturally, socially, and physically. Our facilities are accessible to wheelchair users and those requiring hoists and specialist changing.

We're translating materials into other languages and working with traveller and refugee communities to widen reach. Outreach and subsidised sessions remove financial barriers so that no family is left out.

Our People and Governance

Swings & Smiles is led by a dedicated Senior Leadership Team including our CEO, Operations Manager, Service Development Manager, Fundraising Lead, and Impact Coordinator.

The organisation is overseen by a Board of **eight trustees**, many with lived experience of disability, ensuring our work remains grounded in real family needs.

Staff undergo continuous training in safeguarding, medical care, and inclusive play practice, maintaining our reputation for safe and compassionate care.

Financial Overview (2025-26 Projection)

Our projected annual expenditure is **£660,000** covering staff, facilities, and programme costs. Confirmed income to end March 2026 totals **£450,000**, including funding from The National Lottery, Greenham Common Trust, Baily Thomas, Gerald Palmer Eling, and many community and corporate partners.

Despite a robust and diverse fundraising strategy, we face a shortfall in unrestricted income to meet increasing demand. We are therefore seeking renewed and continued support for our **core running costs** — including salaries, training, and essential programme resources.

Future Plans

Looking ahead, we aim to:

- Expand respite and youth programmes for ages 13+
- Extend our Home Education and Engage provision
- · Recruit and train additional skilled staff
- Strengthen outreach to underrepresented communities
- Continue improving facilities, including sensory and outdoor spaces

While growth brings challenges — limited physical space and stretched funding — our commitment remains unwavering: to ensure every disabled child and their family can play, connect, and thrive.

Conclusion

Swings & Smiles is more than somewhere to play it's a community lifeline. Families find friendship, connections and belonging. Children find joy, independence, and confidence.

Introducing West Berkshire Dementia Hub - Application 21063

I wanted to introduce you to West Berkshire Dementia Hub, a new charity which is seeking startup funds in order to fundraise for a brand-new purpose-designed centre to transform local dementia care.

The number of people estimated to be living with dementia in West Berkshire is projected to increase by 50% by 2030 with an estimated one in two people likely to experience dementia at some point in their lifetime (Alzheimer's Research UK). Without a central plan or funding to tackle this crisis, there is an urgent need to innovate the local model of dementia care to enhance the quality of life for individuals living with dementia and their family carers.

West Berkshire Dementia Hub aims to combine a full range of dementia services in one welcoming community hub to provide integration across health and social care which aims to reduce the fear, social isolation and marginalisation often faced by those with the condition. The centre, which will also provide lots of volunteering opportunities for wider community engagement, will be adjacent to the West Berkshire Community Hospital in Thatcham and negotiations with the NHS to purchase one acre of land are proceeding. In an innovative philanthropic partnership, Greenham Trust will develop, build and own the new centre and lease it to West Berkshire Dementia Hub who will manage the operations inside the building with stakeholder partners. Greenham Trust has almost 30 years' experience of charity and business property development.

The application for planning will be ready to submit to West Berkshire Council in early 2026 with the objective to start building work in early 2027 and for the hub to open during 2028. The project is charity led, and we seek essential funds to accelerate delivery of the project and to launch a major fundraising campaign during October.

The project is expected to cost around £4m, including the purchase of land, building and fit-out costs. Greenham Trust has committed up to £1.5m towards the capital costs which will be awarded as matched funding via its funding and fundraising website.

The Good Exchange to help attract new grants and donations. The Trust and the Hub will also shortly be approaching funders to seek further matched funding for the project.

However, first West Berkshire Dementia Hub needs to raise c. £45,000 start-up funds to enable the marketing, fundraising and IT preparations necessary to launch the public capital fundraising campaign in early October 2025.

West Berkshire Dementia Hub - Application 21063

I wanted to update you on the progress of the West Berkshire Dementia Hub, the groundbreaking project which will transform dementia care in West Berkshire. The charity, working in partnership with Greenham Trust, has appointed HNW Architects to create detailed drawings in readiness for a planning application (see their preliminary design brief attached) in early Spring 2026 which will coincide with a national fundraising campaign launch. Construction of the new hub will commence in 2027 and the building is scheduled to open in 2028. Final specifications for the building will of course be subject to ongoing discussions and clarifications with the NHS, dementia care providers as well as those who have dementia and their carers.

Inside the purpose-designed building will be the NHS managed Memory Assessment Service, a Technology Zone, respite activities, a one-to-one Wayfinding support service, charity partner spaces, therapy spaces and at its heart a welcoming community café.

There are detailed discussions happening now with the NHS regarding the Memory Assessment Service in West Berkshire Dementia Hub. Age UK Berkshire has already said it wants to have space in the hub, as does Young People with Dementia.

Alex Gild, Deputy CEO of Berkshire Healthcare NHS Foundation Trust shared his endorsement to the new dementia hub.

"Berkshire Healthcare NHS Foundation Trust is delighted to support the development of the West Berkshire Dementia Hub. This is a journey of real partnership with a visionary and ambitious charity and funders. As the operator of West Berkshire Community Hospital and the provider of local NHS memory services, we see the huge potential for this development to enhance and integrate services for people living with dementia, their families, carers, the community, and the broader health economy. I am excited to see the fruition of this beautifully designed building in service of people who will benefit from the life-affirming support and sense of community from this innovative new service."



- A simple site layout is proposed with the building occupying the western portion of the site, away from potential flood risk
- The existing access point from Turnpike Road will be reused and enhanced – Transport and Highways input required.



- The site area is set back from the existing ditch on the northern boundary and existing hedgerows and trees are retained to maintain site biodiversity
- The site access leads directly and efficiently to a parking area (sized for 50 vehicles with a proportion of disabled bays).
- A drop-off area to the north of the building leads to the main hub entrance
- The building consists of three contextually appropriate pitched forms with the central pitch containing the main hub entrance and cafe space, light-filled and welcoming and linking directly to the courtyard garden orientated to south
- Activity spaces, therapy rooms, MAS suite, wcs and staff areas are accessed off the cafe space via two wings that wrap around the courtyard garden space that forms the green heart of the building
- There is the potential for the hub to expand to the south in the future by extending the garden corridors and wings to the south
- The site is wrapped in a buffer of perimeter planting to provide screening










