

Public Rights of Way Working Group (PROW WG) - update

Group Remit:

To provide advice to the Planning & Highways Committee about the impact of 2026 deadline in respect of PROW changes.

To review all PROW in the Town Council's area and confirm validity.

To propose new PROW for consideration by P&H.

To prepare submissions for any new PROW proposed by P&H.

Background

Legislation passed in 2000 gave a deadline of 2026 to register all Public Rights of Way that pre-date 1949. Any that are not registered would then be extinguished. The government has legislated to extend this deadline to 2031. although that extension has not yet been implemented

All councils have a considerable backlog of applications. Interest and awareness has been building, including a campaign by the Ramblers Association called "Don't Lose Your Ways". TV attends its West Berkshire meetings, which are held at Bowlers Arms. A recent application to WBC is likely to be assessed in 18 months to 2 years.

Once assessed, WBC can issue a definitive map modification order (DMMO). However if there are any objections it will be passed up to the Planning Inspectorate which will make a determination, generally by Public Inquiry. This is a long and potentially expensive process if there is a committed challenger.

Progress

Following its first meeting the Group has conducted an initial review of Wash Common including a walk round of some potential PROWs. We have also met with Stuart Higgins, WBC's Definitive Map Officer to discuss how we should take this process forward

There are a number of "cut through" that pedestrians use regularly that are not on the Definitive Map and are good candidates for PROW applications

However the discussion with Stuart Higgins has also indicated that unclassified roads, private streets and private roads may also need PROW applications to preserves (public) access rights in the future. There are quite a number of these in the Town and these could increase the volume and complexity of the exercise

The definitive map is not necessarily definitive so further research is usually required to determine the status of a road or pathway.

It is possible for a town or parish council to agree the voluntary addition of a PROW with its landowner. This could be useful as part of the planning process. For example ensuring public access is guaranteed through the Eagle Quarter during the planning process, albeit using separate legislation.

However voluntary dedication can also be done retrospectively using Section 30 of the Highways Act 1980 "where such a dedication would in the opinion of the [town] council be beneficial to the inhabitants of the parish or community or any part thereof". This also applies to routes in an adjoining parish.

Where a voluntary agreement to dedicate a route is not possible, Section 31 of the same Act applies and this process requires the Highway Authority to use its powers. This is where Stuart Higgins is involved here in West Berkshire.

We are focussing on Wash Common currently. Our aim is to identify a process and scope that can be applied to the whole town. It is likely that we will then propose that all Councillors are invited to use their own local knowledge to cover the rest of the Town. Other individuals can be co-opted as well if we need help.

Next Steps

A further review of Wash Common to identify a comprehensive list of potential PROWs A discussion with Stuart Higgins about the list to decide the practicalities of these applications To come back to this committee to review the position and recommend the way forward..
