Re: 20853 – West Berks Foodbank – Hungry Holidays 2025

Dear Town Council Clerk,

I am writing to you on behalf of West Berks Foodbank to request your kind support for our Hungry Holidays initiative, a program dedicated to alleviating food poverty among vulnerable families during school holidays.

The West Berkshire Foodbank routinely supports people who are in food crisis through professional referrals, providing supplies of food and other essential items. Our aim is to not only address short term needs but also to provide support, detect abuse and aim to provide a path out of hardship for those who seek out our service.

In addition, during the holidays we bulk deliver food to local schools to be distributed to carefully selected families identified by school welfare officers. These families include both pupil premium children and those from working families who, despite struggling financially, do not qualify for additional governmental support. These working families are often the most concerning, as parents frequently sacrifice their own meals to ensure their children are fed.

The challenges faced by these families have been exacerbated by rising mortgage rates—some households have seen increases of over £400 per month upon coming off fixed terms—as well as soaring rents, utility and food costs. Families with children who have food allergies or require free-from foods are particularly affected, as these products can cost up to three times more than standard options, further pushing them into food poverty.

While pupil premium children will receive £60 from West Berks Council over the holidays to assist with lunches, this amounts to £10 per week. For children at home, this is insufficient, as their eating habits expand beyond structured meals to include snacks and drinks. For instance, in one day, it's not unreasonable to estimate that a child might consume a bag of crisps, a cereal bar after playing outside, a drink of squash, a piece of fruit, and lunch—expenses that quickly surpass £10 weekly. This is precisely why West Berks Foodbank established the Hungry Holidays initiative.

In the past, we have relied on community donations to support families in need. However, the cost-of-living crisis has led to a 50% decrease in donations, even as demand continues to rise. For this reason, we are reaching out to our local councils for financial assistance to ensure this vital program can continue to operate.

Your funding could make a genuine difference in helping us support vulnerable families who are struggling to make ends meet. Together, we can ensure that no child or parent faces the distress of food insecurity during the holidays.

Please let us know if you would be able to contribute to this initiative or if you require further information. I would be happy to discuss this with you in more detail or provide specific numbers of children in your area and the impact of the program.

Thank you for considering this request, and for your commitment to supporting the well-being of families within our community.

We have a project on The Good Exchange that will allow any donation to be match funded.

Dear Councillors

We are writing to request that you kindly consider Life Education Wessex & Thames Valley (LEW&TV) for a grant towards our work of providing health and wellbeing workshops to approximately 226 children at Robert Sandilands Primary School and Nursery on the 30/09/25 for 2 days.

The cost to deliver our workshops to schools is £540 a day; schools contribute approximately 70% of this, and we need to raise the shortfall. We will be delivering workshops to the school for 2 days, which equates to a shortfall of **£310**. We do not expect your Council to contribute the whole of the difference, but obviously that would be fantastic if you were able. Nevertheless, any contribution you could make would make a real difference to outcomes for local children and families.

Background: LEW&TV is an independent and self-financing charity and delivers the UK’s leading health and wellbeing education Workshops, ‘Coram Life Education’, to children (aged 3–11 years) across Dorset, Somerset, Devon & Cornwall, Hampshire & the Isle of Wight, and the Thames Valley (Buckinghamshire, Berkshire and Oxfordshire). In the 2023/24 financial year over 74,000 children experienced our workshops with another 43,400 benefitting from online resources available to their schools.

Our strap line is **‘Helping Children Make Healthy Choices’** and the programmes address many of today’s topical health and wellbeing issues. Our core programmes help children understand:

- how their bodies work
- what they need to do to look after themselves
- the adverse effects of drugs, including alcohol, tobacco and so-called legal highs
- and learn the skills and gain the confidence to make and implement healthy decisions

We also offer;

- Mental Wellbeing workshops that provide children with the skills and positive mental attitudes they need to be resilient and bounce back from setbacks, help them feel empowered and enable them to identify and articulate their needs and feelings.
- Relationship Education workshops that help children to be aware of their human/physical/sexual rights and know how to protect themselves or others, as well examining healthy and unhealthy relationships, human reproduction and changes at puberty.

Why Life Education is so vital: Children and young people face increasing pressure and temptation to damage their health and their futures.

Research shows that children who have better health and emotional well-being do better in life – both academically and socially. Children are also facing growing pressures at home, at school and with their friends, leaving many primary school pupils ill-equipped for life at secondary school and beyond.

- 41% of boys and 35% of girls aged 10-11 were either overweight or obese
(Source: Office of Health Improvement & disparities 2021/22)
- 18% of children aged 7-16 were identified as having a probable mental disorder, up from 16% in 2020
(Source: Mental Health of Children and Young People in England 2022)
- 9% of children aged 8-15 had ever used e-cigarettes or vaping devices, up from 7% in 2018
(Source: Health Survey for England 2021)
- 20% of 8-11 year olds who go online say they have seen something worrying or nasty
(Source: OFCOM Media Use & Attitudes Report 2023)

Early intervention can prevent mental health problems, obesity and substance misuse in children now and in later life and helps to prevent drug and alcohol-related crime and anti-social behaviour. Our work not only benefits children’s health and their futures, but also promotes healthier families and safer communities.

Life Education workshops empower children with key thinking, learning and social skills to make healthy choices and stay safe online and in the real world. Children graduate

with confidence, knowledge and resilience to cope with the stresses of secondary school and life beyond.

Workshop Delivery: Our workshops can be delivered in either in the schools' own classrooms, in the LifeSpace which is an innovative inflatable classroom, or via SCARF Live Online, which uses ZOOM virtual video technology. Workshops focus on the mental health and wellbeing of children.

Schools also have access to **SCARF**, a comprehensive, interactive and flexible set of online resources which supports the entire PSHE curriculum.

Through our annual delivery, children progressively acquire the skills and knowledge to make their own healthy choices in life. As well as helping the children who participate, the benefits of this preventative education cascade out to the wider community, as children who make the right healthy choices grow up to become better citizens and make a positive contribution to society.

We look forward to hearing from you and hope that ***you will be able to continue helping us to help your local children make healthy choices.***

Thanks so much for the call - I really appreciate you getting in touch.

I've just spoken with our Community Engagement Coordinator who will be one of the people running the Young Curators project.

She tells me that the project will be marketed through the secondary schools in Newbury, as well as marketed through other Newbury-based partner organisations, such as iCollege.

Although we can't confirm that 100% of the young people involved in the project will be from Newbury, as we will be marketing to other areas too, our previous experience leads us to expect that many of the young people will be from Newbury.

If funding were dependent on a certain number of young people being from Newbury, we likely have this flexibility.
